Florida KidCare Matching Grants

Matching grants are tasked with providing targeted innovative activities, ideas and methods to facilitate the enrollment and retention of enrollees.

Florida KidCare Regional Navigator Projects

Regional Navigator Projects are tasked with serving as multi-county Florida KidCare liaisons which includes but not limited to being responsible for promoting the Florida KidCare program, recruiting and training local organizations to serve as Certified Application Assistance Sites and providing technical assistance as requested.

Florida KidCare School Based Projects

School based projects are responsible for overseeing application assistance sites, promoting the Florida KidCare program, providing Florida KidCare information throughout their school district, as well as participating in local events.
